
Thank you to the local organising committees of each of these congresses for taking on the responsibility of organising our annual meeting.

#### Membership Secretary – Keelin O'Driscoll

Once again membership renewals have been going very smoothly, and the membership continues to grow. As of 23 June there are 585 members in the database, which is an increase on last years' number of 547, and in fact the highest number since June 2010! 431 members have already renewed for 14/15, and renewals are still coming in steadily. The pie chart shows a breakdown of our membership by type. #### New members

We have welcomed four new ISAE members in our region: Eva Van laer, Jasper Heerkens and Lisanne Stadig (Institute for Agricultural and Fisheries Research – ILVO, Belgium) and Sanne Ott (KU Leuven, Belgium).

#### Inquiry and group discussion on Benelux ISAE

During the regional Meeting held on 10th of October 2013 (reported in one of the previous newsletters) we conducted an inquiry and organized short group discussions to get an impression of our regional members' ideas on future ISAE-Benelux activities. Below we give a short summary of the outcome.

Almost all attendants of the regional ISAE meeting answered our questionnaire (n=44, 96%). From the attendants 35% were ISAE members, 26% were non-members and 40% was considering membership (2 persons actually became members). We were very happy to learn that 80% of the attendants indicated that they would attend future meetings. The other 20% indicated they would probably attend future meetings. The majority of the respondents (77%) thought meetings should be organized every year, whereas 23% voted for every 2 years. Most attendants (93%) thought that one day was an appropriate length, whereas 33% indicated that a 2-day meeting would (also) be suitable. On average, our attendants felt that 59% of the meeting time should be devoted to presentations, 16% to informal networking possibilities, 10% to formal network possibilities and 16% to excursions of (nearby) research facilities or farms. It was recognized however that it is difficult to organize a short excursion to an animal facility due to hygiene protocols.

The group discussions revealed that people would like additional information on other attendants (and their research groups), so they would get a better idea of whom to approach to discuss specific topics or techniques. In addition, they felt that the Benelux ISAE should stimulate the organization of courses on animal welfare/behaviour and research methodology, not only for PhD. students but also for other researchers. The idea of having an on-line Benelux platform for announcing internship positions was put forward. Several groups indicated that an ISAE-Benelux newsletter with information on conferences, courses and lectures would be helpful, but there was a lot of variation in what was thought to be an appropriate frequency (from 2x a year to monthly). People varied in their opinion on the target audience for ISAE-Benelux meetings. Whereas some groups said they missed the attendance of people from NGOs and industry, others indicated that having a "scientific only" audience was very helpful for the conference. People missed the attendance of people working with lab, companion and zoo animals and felt the Walloon region and Luxemburg were underrepresented.

### ISAE Benelux activities

In addition to regularly updating the Benelux webpage and posting news relevant for our regional members, every now and then we receive questions (e.g. from students seeking a suitable research group). We plan to organize a regional meeting in the autumn of 2014 or spring 2015 and are currently looking into possibilities for other activities based on the questionnaire and group discussion results.

### East Central Europe - Radka Šárová and West Central Europe - Dr. Edna Hillmann

The main event in 2013 was the "Joint East Central and West Central Europe ISAE Regional Meeting" which was held in Skopje, Macedonia on October 8-10, 2013.

The meeting was organized mainly by the East Central Europe Region in cooperation with the AWARE project. We received the financial support £1000 from ISAE which was used for travel grants for 5 students - Csilla Budai (Faculty of Agricultural and Food Sciences and Environmental Management, University of Debrecen, Hungary), Jana Dubcová (Faculty of Science, University of South Bohemia, Czech Republic), Mária Horváth (Institute of Animal Biochemistry and Genetics SAS, Slovakia), Katarína Pichová (Institute of Animal Biochemistry and Genetics SAS, Slovakia) and Mira Suwala (Institute of Genetics and Animal Breeding PAS, Poland).

**Summary**: Animals and especially poultry welfare is a novel science in Iran. In the last decade, some researches and societies established categories in Iran for the protection of animals against cruelty and pain.




Due to a lack of books in this matter, this book focused on laying hens welfare was published.

The book includes 5 chapters:

- 1- Role of stress factors on performance of laying hens
- 2- Stress factors related to competition in flock
- 3- Stress factors related to nutrition
- 4- Diseases and other stress factors
- 5- Mechanism of stress factors action in body

### About the authors:

Dr. Fathollah Boldaji is a professor in Agricultural Biochemistry and Nutrition. He was born at 1933 in Ramhormoz, Iran. He received his B.Sc in animal science from Jondi-Shapour University in Ahwaz, Iran at 1958. After that, he went to Arizona University, USA and received his M.Sc and Ph.D at 1965 and 1969 respectively. Then he came back to Iran and had 45 years research and teaching in Jondi-Shapour and Gorgan Agricultural University. He published 3 books and has several papers in the animal science field. Now, he is retired and has had collaboration with Gorgan Agricultural University until now.





Dr. Ahmad Tatar is an assistant professor in poultry nutrition. He received his M.Sc. and Ph.D. in animal nutrition in 2006 and 2012 from Gorgan University of Agricultural Sciences and Natural Resources, Gorgan, Iran. After that, he went to Ramin University Agricultural and Natural Resources of Khouzestan, Iran as an academic member. Also, he is the Australasia and Africa regional secretary of ISAE with Rebecca Doyle (AUS) since 2012. He was the 2008 and 2010 recipient of the World Poultry Congress (Australia) and European Poultry Conference (France) grant as youth program. Also, he was granted the Iranian top Ph.D student title in 2012.

Regarding his scientific activities he published two books (in Persian), registered two patents in animal feed additives, published 3 international papers in refereed journals, 40 presented papers at international conferences, 28 papers at national conferences and published 13 papers in Iranian popular press magazines.

## Animal Behaviour and Welfare MOOC



## New Book: The Cognitive Horse

Authors: Francesco De Giorgio and José Schoorl



This book is not a manual. There are plenty of manuals about horses and about their usage, training, and conditioning. The words in this book are dedicated to horses as sentient and sociocognitive living beings, to their world of perception, their acquisition of knowledge, their understanding of the environment, and their social abilities towards each other and towards humans. This focus is necessary, because until now, following the conventional paradigms, horse behaviour has been mostly explained in the context of behaviourism and classic ethology. These interpretations have marked the way we look at horses and how we explain their behaviour, both in their co-existence with each other and in their relationship with human beings. In daily life, many things are erroneously taken for granted, creating the many misunderstandings that horses encounter daily with people all over the world, and vice versa. The way horses live in their social context, how they learn from it, and how they elaborate information from their surroundings and interactions are still thoroughly devalued, causing a lack of proper understanding of their well-being.

The book is divided into three parts, each addressing the cognitive horse from a different angle. The first part, The Invisible Horse, explains how our human beliefs and assumptions have an impact on our perceptions and how that plays a part in making the horse "invisible" as a cognitive animal. It also shows how the large number of elements that support the current universal idea we have of horses makes it more difficult to allow for the observation of relationship dynamics from a different perspective. The second part, A Life Without Tension, introduces the concepts of equine zooanthropology. It describes what happens when a horse grows up in a socio-cognitive context and what it means for the interaction between horses and for the horse-human interaction when these abilities are taken into account. Practical examples are given of horses and their owners who find their way 'back', together, to a reciprocal relationship. In the last part, Growing Together, the human elements are described, and the awareness that is necessary, to be able to understand the dynamics that are involved in the relationship between horse and human where the cognition of both is taken into account. It talks about letting go the habits and thought-mechanisms that create many expectations in our interaction with animals. It also helps to understand where the control issue starts, and how we can go back from a need for control to the perception of contact. With that, it will explain the benefit of developing an eye for detail, and creating a better awareness of our senses

again. Sharing moments and experiences with horses needs expression, room for as understanding of both the nuances in the relationship dynamics and in behaviour. Herd dynamics, and every unique equine-human relationship, are with hierarchic not defined protocol, but depend on the surroundings, on inner motivation, on the social context, on previous experiences and many other elements. This makes every relationship a life-long journey of shared experiences and discovery.
