We had an excellent international Congress in the lively city of Aarhus, with great talks, great networking, great dancing and a great atmosphere in general. I would like to take the opportunity once again to thank Margit Bak Jensen and her team for the excellent organisation and all participants for their contribution to this wonderful meeting. A special occasion this year was the start of the Developing Countries Congress Attendance Fund (DCCAF), funded by the Open Philanthropy Project. This fund allowed us to bring 14 people from developing countries to the Congress – a unique opportunity for the ISAE to help develop applied animal behaviour and welfare science in parts of the world where the field is still in its infancy. It would be great if we could continue this work in years to come.

The <u>2018 Congress</u> (<u>http://isae2018.com/</u>) looks equally promising as last year's! We are invited to join Michael Cockram and his team on the beautiful Prince Edward Island, Canada from 30 July until 3 August 2018! The overall theme for the Congress is 'Ethology for Health and Welfare.' The organisers plan to have the excursions during the Congress, providing opportunities to visit Prince Edward Island National Park, to go sea kayaking, or visit Anne of Green Gables. Something to look forward to! Apart from the international Congress, of course also a number of <u>regional</u> <u>meetings</u> is organised every year. The regional ISAE meetings are of special interest to local MSc and PhD students and sometimes focus on specific topics.

On 8 August 2017, our Annual General Meeting (AGM) was held. The meeting was well attended by 95 people, of which 82 were members. It was good to see so many of our members take an interest in the running of the Society. Much of what was discussed at the AGM can be found in the officers' reports in this newsletter and in the previous issue. A point of special interest for this AGM were the changes to the Constitution to allow the ISAE to become a Scottish charitable organisation. Birte Nielsen guided us through this challenging process, and we are now almost there. Some further changes were required, which we can hopefully confirm in the 2018 AGM in Canada. Another important point from the AGM was making the position of Development Officer a voting ISAE Council position. We feel this is important because helping certain countries develop their applied animal behaviour and welfare science is becoming an important part of our work. This position was confirmed at the AGM and Rebecca Sommerville was officially voted in as a full Council member. At the AGM, we also voted in Susanne Waiblinger as Junior Vice-President, Marisa Erasmus as Secretary, Emma Baxter as Treasurer, and Irene Camerlink as Junior Editor. Jeremy Marchant-Forde, Jean-Loup Rault, Krista McLennan and Margit Bak Jensen were all leaving Council: thank you so much again for all you have done for the Society!

If, as an ISAE member, you would like to take part in the running of our Society, I would encourage you to consider standing for election for one of the 4 Council positions that will be up for renewal at next year's AGM: **Membership Secretary**, **Procedural Advisor**, **Education Officer** and **Ethics Officer**. You can find out more about these positions by consulting the ISAE <u>Procedural Guidelines</u>.

Apart from the topics described above regarding ISAE development, the Council is actively engaged in starting activities with the new <u>Country Liaisons</u> and organising activities leading up to (and including) ISAE 2020 in Bangalore, India. The ISAE is also active in the new <u>EU Platform</u>

<u>for Animal Welfare</u>. Our Senior Vice-President, Birte Nielsen, attended the first 2 meetings and tells you more about them later in this newsletter. Needless to say, the ISAE is very much alive and a very active society! I hope 2018 will be a very good year for the ISAE and for you all and that we will have a great Congress at PEI, Canada. I wish you all the best for 2018 and look forward to meeting you in Canada. Season's greetings!

# ISAE Council News

# Website and Social Media

After months of planning and anticipation, we were thrilled when the revamped <u>ISAE website</u> went live in August during the Congress in Aarhus. We presented a brief video introducing the features of the overhauled site during the AGM. Same address, new site: <u>www.applied-ethology.org</u>. Please check it out and explore the new features!

The website overhaul was the culmination of months of work, including:

- discussions within Council about desired site improvements and priorities
- several rounds of feedback from Council on a new logo design, which debuted in June on the cover of the <u>previous issue</u> of the newsletter and is now found on all of our new communication materials
- input and votes from the membership to select 5 non-equine animals for the new globe image featured on ISAE print materials
- soliciting >300 beautiful animal photos from members to be featured on the site
- extensive communication and feedback to Intergage (our web design and host partner) on the design and features of the site, its preview pages before the go-live, the project's progress, and issues and solutions

Since then, I have used the new brand imagery to create updated letterhead for Council business and have redesigned the leaflets, poster, and PowerPoint slides used to promote membership in the ISAE. This includes help from the regions in translating these promotional materials into multiple languages, and this project is ongoing. With the launch of the upgraded site, we also decided to shift the task of updating each regional page from the Regional Secretaries to the Communications Officer to streamline both the process and the look of the pages among the regions. The regions, along with Development Officer Rebecca Somerville and the new Country Liaisons, have been generating lots of new content for their pages. I am working with them and the new JuniorVice-President, Susanne Waiblinger, to determine what members want from their regional pages and how to best achieve consistency.

In addition to growing the regional content, every week, we continue to post new <u>employment and</u> <u>educational opportunities</u> and <u>news or requests</u> from ISAE members online. We are particularly focusing on featuring peer-reviewed scientific <u>papers</u> published by ISAE members. Highlighting peer-reviewed papers has proven to engage our audience as well as promote animal behaviour and welfare science. Beginning in January, we will automatically share all papers published by ISAE members in *Applied Animal Behaviour Science*. ISAE member Emma Bruun with Elsevier has kindly been compiling the links for us. If you wish to **opt out** of this automatic sharing of your work, please email <u>isaebusiness@hotmail.com</u>.

We encourage all members to share with us their **open-access papers** or **temporary author links** from other publications (i.e., the URL in your author email from the publisher – not the DOI or ScienceDirect link). For permanent open-access papers, if possible, please include a high-resolution photo *at least* 650 (width) × 400 (height) pixels (larger photos will be cropped to fit; all photos must be in landscape orientation). Otherwise, either a relevant photo submitted by other members, a stock image, or a plain coloured background will be featured with your paper.

We are still working out some minor issues with the new website interface, and we welcome your feedback and ideas (<u>isaebusiness@hotmail.com</u>).

During the AGM in August, we leveraged communication tools to introduce some metrics around the ISAE social media activities that were started in the past year. One of our goals was to grow our online community...and from August through the end of November, we doubled our followers on both Twitter and Facebook! We subsequently doubled our reach and the number of clicks on content – an encouraging sign of engagement with our community.

Two factors pop out as highlights that drove increased engagement: use of strategic management and our #ISAE2017 Congress in Aarhus. In August we started using a social media management tool, Hootsuite, which helps spread out content over time and post at times that are more likely to be seen when our audiences are online (and not just when it's posted in Alberta!). ## Editors' Report

#### Special Issues

The Special Issue of *Applied Animal Behaviour Science* based on the 2016 Anniversary Congress in Edinburgh, entitled 'Tinbergen's 5 Questions,' will contain 8 papers. These will relate to Tinbergen's original 4 questions about causation, function, development, and evolution of behaviour, as well as an added fifth question on animals' subjective experiences. Three manuscripts have been accepted and the remaining 5 are in varying stages of revision.

The special issue based on the 2017 Congress in Aarhus, Denmark, will be themed 'Understanding Animal Behaviour.' The issue is progressing very nicely with 15 authors who have confirmed their contribution, and 4 of the manuscripts have already been submitted and are currently under review. This Special Issue will contain several review papers by the plenary speakers as well as a selection of research papers that were presented by students and postdocs at the Congress.

We would like to take this opportunity to remind all authors who have confirmed their willingness to contribute to the Special Issue to submit their manuscripts as soon as possible. To those who have received an invitation to review a manuscript, please consider the request and provide a response, whether positive or negative, in a timely manner. Thank you!

#### Help with English Scheme

The ISAE has an English grammar and language editing service available to help members prepare manuscripts for publication in *Applied Animal Behaviour Science*. Since the 2017 Congress, we have received several requests for this service to improve manuscripts prior to publication.

Please include the manuscript title, contact information, keywords, and a copy of the abstract. You will be connected with an ISAE member who has volunteered to help you with the English of your paper. #### Development

# Treasurer's Report

Emma Baxter took over from Krista McLennan as ISAE Treasurer in September 2017. There continues to be a period of transition as the hand-over takes place and various permissions are confirmed by HSBC Bank and Global Payments.

This year, the accounts are presented from 31 December 2016 to 8 November 2017. The major revenue came from Membership subscriptions. The 2 largest outgoing expenses were to Intergage for membership services and continued support of the ISAE website, as well as the special project to conduct a major website overhaul, and to Wageningen Press in relation to annual costs for Congress abstract proceedings. Council member costs include reimbursement for travel to the AAALAC Membership Organisation Board meeting in September and for communication-related activities (SurveyMonkey upgrade fee, font purchase for re-branding). There was also travel reimbursement to represent ISAE on the EU Platform for Animal Welfare, which was subsequently recompensed by the EU Commission (appears within Payment returns).

# **ISAE Congress News**

#### 51st Congress, Aarhus, Denmark, 2017

The 51st International Congress of the ISAE took place 7 to 10 August 2017 in Aarhus, Denmark. The theme of the Congress was 'Understanding Animal Behaviour,' and 300 participants from no fewer than 41 different countries took part.

In the wonderful setting of the Music Hall, we were treated to 85 talks and 105 posters on subjects as diverse as the senses and perceptions of animals, maternal and neonatal behaviour, animal stress responses, and the application of ethology in the keeping of animals. The Wood-Gush memorial lecture was this year given by Peter Teglberg Madsen, a local marine biologist, who presented the fascinating world of echolocation in marine mammals to an enrapt audience.



The conference dinner took place in the

historic Turbine Hall in Aarhus. The rustic venue dates back to 1900 and was full of atmosphere and character. Everyone was treated to a fully vegetarian menu, and a local band from Aarhus provided the required dance tunes. When it comes to dancing, the participants did the ISAE proud in terms of stamina, innovation, and general inclusiveness. As usual no partner is required, but you just join and mingle (or – at times –mangle)!

A warm thank you to the Danish organisers for a truly successful Congress, both in terms of the science presented as well as the opportunity to meet up with new and old friends.

#### 2017 ISAE Award Winners

Honorary Fellow. **Dr. Alistair Lawrence** was elected as Fellow of the ISAE and was granted lifetime membership to the Society. Dr. Lawrence has been a long-standing member of the ISAE and served as Secretary from 1986 to 1991 and as Chair of the Wood-Gush Memorial Lecture Committee for many years. He has been actively involved in research and education in applied animal behaviour and animal welfare for more than 30 years, since completing his PhD under



David Wood-Gush in 1984. He was instrumental in setting up the University of Edinburgh's MSc in Applied Animal Behaviour and Welfare in 1991 and still teaches on this Course to this day – the longest-serving member of the teaching committee! He led the Animal Behaviour and Welfare research group at Scottish Agricultural College (and then Scotland's Rural College) for 25 years, before stepping down to focus on research. During this time, Dr. Lawrence has supported, encouraged, and mentored very many young animal behaviour scientists, some of whom are now themselves active in the ISAE and in other prestigious organisations and institutions around the world. More information about Dr. Lawrence's work can be viewed online.

Creativity Award. This year, the recipient of the Creativity Award was **Dr. Françoise Wemelsfelder**, who clearly meets the criterion of 'a candidate who, displaying exceptional creativity, has contributed a method that has had a significant impact on

the field of applied ethology.' Dr. Wemelsfelder developed the method of Qualitative Behaviour Assessment (QBA), a method that allows a 'whole-animal' methodology and integrates information from multiple behavioural signals and body language to interpret an animal's emotional expression. The method has been very important in the development of practical welfare assessment protocols, such as the Welfare Quality protocols, and has also facilitated communication with other stakeholders about animal welfare. The QBA method is not

uncontroversial, but we believe this discussion about how we can assess animal welfare and how we can include subjective feelings has helped advance the field. Dr. Wemelsfelder's biography can be viewed online.

New Investigator Award. The recipient of the 2017 New Investigator Award was **Dr. Irene Camerlink**. Her award proposer characterised her as *the* model postdoc. Dr. Camerlink is currently applying game theory to understand the resolution of conflicts between unfamiliar pigs. Both her PhD and her postdoc have been in truly multidisciplinary fields and she embraces new and original approaches, showing great creativity. Dr. Camerlink is involved in student supervision and in international collaborations. She is also very successful in presenting and publishing her work (often open access). She obtained her PhD from Wageningen University and is currently a postdoc at Scotland's Rural College in Edinburgh. Her biography can be viewed online.

#### Global Development Lunch

As part of our efforts to make the ISAE a truly global society, we organised a Global Development Lunch for attendees from Africa, Asia, Latin America, the Middle East, and Eastern Europe at the international Congress in Denmark. Many were recipients of the first Developing Countries Congress Attendance Fund (DCCAF), as well as both new and continuing members of ISAE from around the world.



After lunch and networking, we asked participants to share their views on the following questions:

Why is the ISAE not well represented in your country or region? Answers included a lack of awareness of ethology and animal welfare, little funding, few individuals working in the field, and other issues such as productivity or human welfare taking priority.

What support would be useful from the ISAE? Answers included easier open access to journals, capacity for building training in animal behaviour or welfare, building partnerships between universities, providing grant or travel attendance funding, sharing information from a wider range of countries at ISAE events, and supporting better links among countries within regions.

What are your ideas for promoting ISAE in your country? Answers included:

Africa:

- Ethiopia making links through the veterinary association and education forum
- Ivory Coast diffusing information through the OIE focal points
- Nigeria providing resources or videos to help train farmers on better husbandry practices and transport systems. Information shared by email could be passed on to academics and private farm veterinarians.

#### <u>Asia</u>:

- China Hold ISAE events in the country. Support establishment of animal welfare organisations.
- Japan ISAE is already promoted and very active. Encourage more regional activity with other Asian countries.
- Malaysia Organise or attend local seminars to promote both animal welfare and the ISAE. Propose members to get involved with local research.
- Philippines inform the government, particularly the animal industry government agency, which is the implementer of animal welfare, as well as veterinary and animal science associations
- Nepal ISAE could introduce a student chapter in a Nepalese university; 2 universities are working in animal science, but there is less focus on animal behaviour and welfare
- Vietnam Invite representative researchers as members of ISAE. Provide support for conference or meeting attendance.

#### Central and South America:

- Brazil Make partnerships with animal welfare research groups. Prepare teaching materials in Portuguese.
- El Salvador Liaise with the national university and others in Central America so ISAE members could get involved in MSc projects there. Characterise production systems to identify the main welfare problems and try to find sustainable solutions.

We hope to use this learning to continue to promote ISAE more widely in new areas, and we ask members to consider how they could support these ideas through their work and networks.

#### **Eating with Ethologists**

During ISAE International Congress 2017 in Aarhus, Denmark, the Eating with Ethologists event was an overall success and included 80 of the total 301 registered Congress attendees. The event was organised by Student Representatives Maria Vilain Rørvang and Megan LaFollette to pair students and faculty with similar interests. Following the event, we sent out a survey to all registered attendees at ISAE 2017. The data from this survey are very interesting, and we have included a brief summary below.

Overall, people who attended were very satisfied with the event! We received 108 responses, of whom 52% attended the event (35 students and 21 non-students) and 48% did not (15 students and 37 non-students). Those attending thought the event location was clearly marked (96%) and were satisfied with the event overall (95%). Of those not attending, their reasons were: not seeing the invitation at all or too late (27%), being too



busy (25%), or thinking that the event was exclusively for students (11%).



We received many positive comments and suggestions to help improve the event. Attendees thought the event was enjoyable, beneficial, and organised, appreciated its relatively informal nature, and appreciated the 2:1 ratio of students to professors. Three key suggestions were to confirm signups and pairings earlier, increase event promotion (make it a question during registration, make an oral announcement during

the opening reception, highlight it in the newsletter, include a flyer in the registration bag), and increase clarity around the event (change the name/information to make clear that it matches students and professors, more specific designation of professor interests, provide professor interests during onsite signups). Additionally, attendees suggested more iterations of the events at a variety of times and having multiple servings through the event or lunch served at the table.

#### 2019 and beyond

It is always a good idea to make a note of the upcoming ISAE Congresses in your diary. In 2019, it will take place in Bergen, Norway from **5** to **9** August 2019 (<u>www.isae2019.com</u>). The 2020 Congress will be in Bangalore, India, and the dates for this Congress will be determined soon.

It is no secret that taking on the organisation of a Congress is no small job. However, it can be great fun, and for some past organisers it has functioned more as a team-building exercise, strengthening the collaborations within the research group in charge. Also, with the increasing size of the Society, it is often not possible to organise and run a Congress without the assistance of a professional conference organiser and other paid assistance; indeed, most of the recent organisers have used this option. We are currently looking for bids to host the ISAE Congresses in **2021** and **2022**. As we strive to alternate between European and non-European venues, we would like to invite bids from potential European hosts for the 2021 Congress and from hosts outside Europe for the 2022 Congress. We are, of course, also open for suggestions for venues even further into the future. Please do not hesitate to contact me, even if you are only 25% drawn in and 75% in doubt – we are interested only in helping you decide. No pressure. Honest.

#### Congress Attendance Fund

I would like to remind you all of the existence of the Congress Attendance Fund (CAF). The CAF is set up to support the attendance of ISAE members at the annual Congress. The fund will be no less than £2 000, which will be allocated to needy ISAE members to contribute toward the Congress registration fee or accommodation (but not usually travel).

To be eligible, the applicant must be a member of the ISAE before submitting their application. The applicant must have submitted an abstract, and money will only be allocated if their presentation is accepted. Applications for funding will be reviewed by the CAF Committee and will be prioritized on the basis of financial need and quality of the abstract. Researchers and students from developing countries are especially encouraged to apply for this support. Please note that support from the CAF to any one person is limited to once in any 5-year period – if you have received funding in the last 5 years, please do not apply.

The application must contain all of the following information:

- 1. Name of applicant
- 2. Postal and email address (or fax number)
- 3. The year the applicant became a member of the ISAE
- 4. Status of applicant (e.g. student, active researcher, unemployed researcher, etc.)
- 5. A full justification explaining why the applicant should be given an award. There is no fixed format for this justification, as reasons will vary between applicants, but if no justification is given, the application will not be considered.
- 6. A budget for attending the Congress, including a statement of which part(s) is requested from ISAE and whether other funding is available to cover parts not funded by ISAE

The application itself <u>must not be more than one A4 page</u>. It must be accompanied by a short CV, including a list of publications and/or presentations by the applicant (including local and regional meetings) and a copy of the abstract submitted for the Congress.

Applications are due **5 March 2018** and should be sent to Birte L Nielsen (<u>birte.nielsen@inra.fr</u>). Successful applicants will be notified immediately following acceptance of Congress abstracts. For more information, see the <u>Procedural Guidelines</u> on the ISAE website.

# ISAE Regional News and Development

# Introducing our Country Liaisons

Following advertising earlier this year, we are delighted to introduce our 3 new Country Liaisons. The position is held for 2 years by a focal-point member in a country where ISAE is underrepresented and has potential to develop. # Brazil

Andreia De Paula Vieira (apvieirabr@gmail.com) is the Technical Manager for <u>Centro de Pesquisa da Universidade Positivo (CPUP)</u> and Professor of Animal Welfare and One Health in the Faculty of Veterinary Medicine, Universidade Positivo (UP). CPUP, a multidisciplinary research center, and the Veterinary School are located in Curitiba, Brazil. Andreia is a veterinarian who also received her PhD in animal science from the University of British Columbia (UBC, Vancouver, Canada). While at UBC, she studied the effects of early social interactions on calf responses to novel events. Andreia received her MSc from Universidade Estadual de Londrina (Brazil), where she investigated hunger indicators in dairy calves.



Between 2012-2015, Andreia served as project coordinator for the Animal Welfare Indicators Project (AWIN - WP4), where she led the development of the information architecture for the Animal Welfare Hub and a team of IT developers and designers in Brazil. The Hub integrates current information from animal welfare science (e.g., by using learning objects both derived from the AWIN project and elsewhere), recent literature in animal welfare education and topical societal debates into interactive knowledge environments.

As Country Liaison for Brazil, Andreia is promoting external connections with the ISAE, as well as supporting the Regional Secretaries in organising the next Latin America regional meeting through the involvement of Brazilian members.

#### India

Dr. Vijay Pal Singh (vp.singh@igib.res.in) works as Veterinarian (Senior Technical Office-III) in the CSIR-Institute of Genomics and Integrative Biology and as Assistant Professor in the Academy of Scientific and Innovative Research (AcSIR). He is a Graduate in Veterinary Medicine, Postgraduate in Dairy Husbandry and Milk Processing, and has a Doctorate in Biotechnology. He is a specialist in Lab Animal Science and Animal Welfare trained at Utrecht University, The Netherlands and Cambridge University, UK, and an Ad-hoc Specialist, International Association for Assessment & Accreditation of Laboratory Animal Care (AAALAC). He was involved



as an Ambassador, Systematic Review Centre for Laboratory Animal Experimentation (SYRCLE), Radboud University, The Netherlands, and studied Animal Welfare Ethics and Law from Cambridge University, UK.

As Country Liaison for India, Vijay is promoting the ISAE, especially around Delhi, and is supporting other ISAE members in India to plan national-level activities to raise awareness of the ISAE ahead of the 2020 congress in Bangalore. Lately, he became interested in animal welfare and behaviour and organised multiple courses. conferences. and seminars. This year, they ran an international conference on 3Rs and laboratory animal science in Delhi. The conference was a huge success with 300



participants from 5 continents, and 100 people participated in the pre-conference workshop. India is on the cusp of revolution, and animal welfare is very central to people's day-to-day life. Vijay wishes to bring an ISAE national meeting to Delhi next year to set the scientific standard on animal welfare and behaviour.

#### Serbia

Mirjana Đukić Stojčić (mirjana.djukicstojcic@stocarstvo.edu.rs) studied animal production at University of Novi Sad, Faculty of Agriculture, and graduated in 2000. In 2003, she finished Masters studies at Weihenstephan University in Germany (DAAD scholarship). From 2003 to 2006, she obtained PhD at Hohenheim University in Germany on the DFG Project 'The effect of locomotor activity and weight load on bone health in fast and slow growing chickens.' From 2008, she has been employed at the Faculty of Agriculture in Novi Sad, Department of Animal Science, as Associate Professor for Farm Animal Ethology, Nonconventional Animal Production, and Poultry Science. Her research focuses are on poultry behaviour, domestic animal behaviour, poultry welfare, and meat and egg quality. She continues to carry out studies related to broiler behaviour and their activity as well as the impact of broiler activity on foot pad dermatitis. Serbia is already in the process of regulating and adapting its welfare practices in accordance with EU standards. For example, in Serbia, change from the conventional cage system to the alternative systems is still in process, although it is certain that it will be the responsibility of producers by 2020. Current research by Mirjana and her team is related to investigating the effects of perch arrangements in furnished cages on KBD (COST Action: 'Identifying causes and solutions of keel bone damage in laying hens'). Through this action, she will try to promote applied ethology to students, producers, and consumers, and explain why it is important to know and recognize the natural behaviour of domestic animals. It also enables her to continue to resolve the problem of keel bone damage that improves animal welfare and farm productivity.

As Country Liaison for Serbia, Mirjana plans in 2018 to actively promote applied ethology in ex-Yugoslavian countries with the aim of increasing the number of ISAE members in the region. She would also like to become a member of the animal welfare group for the Ministry of Agriculture and Environment in Serbia, and promote applied ethology



through cooperation and assistance by the ISAE, because the group hasn't been promoting applied ethology to producers and the public in Serbia so far.

# **Regional Updates**

#### Australasia-Africa

# Other News

#### Update on Application for Charity Status

As you all know by now, the ISAE has for some time been applying for charitable status to become a Scottish Charitable Incorporated Organisation (SCIO). To this end, we made extensive changes to our <u>Constitution</u> at the AGM in Denmark on 8 August 2017. Unfortunately, a new rule had recently come into force, according to which we also needed to include a specific 'non-profit distribution clause' in our constitution:

'The Society has power to do anything which is calculated to further its purposes or is conducive or incidental to doing so.

No part of the income or property of the ISAE may be paid or transferred (directly or indirectly) to the members – either in the course of the Society's existence or on dissolution – except where this is done in direct furtherance of the charitable purposes of the ISAE.'

In plain English, this means we can spend our money on anything we want, provided it in some way furthers the aims of the ISAE listed in our Constitution. If money is paid to any of our members (e.g., travel cost refunds), this can be done only for costs incurred in connection with our charitable purposes, which are the advancement of science, education, and animal welfare.

The ISAE Council could see no problems or constraints in this clause, and I thus sent out an email to all ISAE members on 1 November 2017, suggesting that we insert the missing clause in a draft revision of the Constitution, to be sent to the Scottish Charity Regulator (OSCR) for approval to avoid delaying the application process unnecessarily. No members protested this procedure, and our application was re-submitted together with the draft version of the Constitution.

#### I am very pleased to announce the ISAE has been awarded SCIO status as of 5 December 2017.

Council will therefore formally propose to the ISAE membership before the next AGM in August 2018 that the clause above should be formally included in the Constitution, following the usual procedure for Constitutional changes outlined within it. If the change is not approved by two thirds of the members present at the AGM in August 2018, we withdraw our status as an SCIO.

# EU Platform for Animal Welfare

The European Union (EU) has established a Platform for Animal Welfare, of which the ISAE is a member. The official representative is our President, Bas Rodenburg, with the Senior Vice-President, Birte L. Nielsen, as the substitute. The platform meets twice a year in June and November, and Birte has attended the initial 2 meetings, held on 6 June and 10 November in Brussels, Belgium. Attendance at these meetings is covered by the EU, so our participation is at no cost to the Society. The platform has representatives from all EU member states, and from international animal-related organisations, such as the FAO, OIE, and EFSA, as well as 40 representatives consisting of independent experts, civil societies, and business or professional organisations. The ISAE belongs to the latter category.

The purpose of the EU platform is threefold: 1) to promote a better implementation of EU legislation, 2) to encourage voluntary and verifiable commitments (such as labelling schemes), and 3) to promote the EU standards globally.

Three working groups will be established, each with 20 members. The first will discuss issues related to live transport of animals, and the ISAE has submitted a request to be included in this subgroup. The second subgroup will be established at the next meeting in June and will deal with pig welfare, and the third subgroup will discuss issues related to stunning in connection with slaughter and with emphasis on poultry. Other spontaneous subgroups may be established at the initiative of some of the member states, and subgroups on subjects such as horse welfare and illegal trade in cats and dogs are likely to be created.

The next meeting of the platform is scheduled for 21 June 2018.

#### Animal Welfare Judging and Assessment Contest

The 17th Annual <u>Animal Welfare Judging and Assessment Contest</u> was held on 18 and 19 November 2017, at Iowa State University in Ames, Iowa, USA, organised by ISAE members Dr. Anna Johnson and Dr. Suzanne Millman. More than 140 students took part, divided into Undergraduate, Graduate, and Veterinary student divisions. The competition, supported by the American Veterinary Medical Association (AVMA), teaches students to assess the welfare of animals in a variety of settings using science-based methods and reasoning. After weighing the evidence, participants present their evaluations. High scorers win prizes in individual, team, or overall categories. This year, the welfare scenarios were: 1) meat rabbits, 2) farmed fish, 3) racing greyhounds, and 4) finishing pigs, with the finishing-pig scenario comprising the live assessment.

The competition spans 2 days. On the first day, students evaluate a live scenario and present their findings to a panel of judges. This portion of the contest may be competed as a team or as an individual. On the second day, each student independently evaluates 3 virtual scenarios and receives scores based on their evaluations as well as their defense of their findings. For those participating as part of a team, the top 3 individual scores are combined with the live-assessment exercise score to determine the overall team score. Along with demonstrating the welfare needs

of a range of species, the competition gives students the opportunity to develop their criticalthinking and oral-presentation skills. Enhanced knowledge of animal welfare, a strong analytical mindset, and well-honed communication skills are valuable takeaways that serve AWJAC participants throughout their education and careers.

The scenarios were drawn up by Janice Siegford, and judges included ISAE members Stephanie Torrey, Patricia Turner, James Serpell, Becca Franks, Nicolas Devillers, and Jennifer Walker. Teams from Michigan State University and Purdue University won the Veterinary and Graduate Student divisions, with a team from the University of Guelph winning the Undergraduate division. Claire Hovenga, Megan LaFollette, and Heather Pechtl won the individual honors. Congratulations to all participants and many thanks to the AVMA and Merck for their continued support of the contest, together with travel funding from SAVMA and PAACO.

# Remembering Dr. Christopher Sherwin (1962 – 2017)

It is with the deepest sadness that we report the death of Dr. Chris Sherwin on 18 July 2017. Chris was for many years a very active member of the applied ethology community, carrying out influential studies on the behaviour and welfare of laboratory mice and the effects of lighting on turkey welfare. As many will remember, he also contributed greatly to the 2 main academic societies in his field, serving as a member and then Secretary of the Association for the Study of Animal Behaviour's Ethical Committee, setting up and chairing the Animal Ethics Committee of the ISAE, lead authoring the ISAE ethical guidelines, and lead organising the 40th International Congress of the ISAE in Bristol in 2006.

Chris was born in Bradford, England, but spent his formative years in Australia, receiving his BSc (Hons) in Veterinary Biology from Murdoch University in Perth, and staying at Murdoch to study for his PhD on social and thermal influences on shading behaviour in sheep under the supervision of Ken Johnson. He then took a junior research fellowship at the University of New England, where his interest in animal welfare became evident with the publication of a short paper on the effects of electronic tags on ear damage and related behaviour in pigs.

In 1990, Chris moved back to England, joining Christine Nicol's research group at Bristol University Veterinary School, where he was to spend the rest of his academic career. Initially, he worked on broiler chicken and layer hen welfare, and later he made significant inroads into our understanding of turkey welfare and behaviour, publishing 11 papers on this understudied species between 1998 and 2001. He also carried out an important series of studies on laboratory mice, investigating theoretical issues underpinning preference testing and consumer demand methods, and he also used these techniques to investigate motivation for space, nesting material, and other resources.

Chris's highly productive research was rewarded with a prestigious Universities Federation for Animal Welfare Hume Fellowship in 2001, which he used to fund further work on laboratory mouse welfare, including innovative studies of the influence of standard housing on motivation for anxiolytics, and how factors such as cage colour and social context affect preference and motivation. His final experimental studies included work on free-ranging chickens and also zoohoused elephants, allowing him to make the rare claim of having insight into the behaviour of both one of the smallest and the largest land mammal.

Alongside his wide-ranging and productive empirical work, Chris also made notable theoretical contributions, including a paper on invertebrate suffering, which preceded current interests in insect emotion and consciousness by well over a decade, a highly cited review of voluntary wheel running by captive rodents, and an insightful article on the possibility that standard rodent housing may have detrimental effects on the quality of scientific research.

Throughout his career, Chris was a stalwart advocate for animals and their welfare, helping to develop ethical guidelines on animal use for academic societies, implementing ethical assessment processes for papers submitted to leading journals, and sitting on ethical committees at other Universities. He mentored young researchers, was a lively and fun companion at international conferences, and invested huge effort in organising the 40th International Congress of the ISAE at Bristol in 2006. He continued to publish until 2013 and was very active on Wikipedia, creating nearly 50 articles and contributing to many more, and presenting the fields of animal welfare and behaviour with a clarity and authority that will, without doubt, inform and influence many interested students, school children, and members of the wider public. His many scientific papers and his wide-ranging contributions to the fields of animal behaviour and welfare, including his later Wikipedia articles, will be his continuing contribution and lasting legacy to our discipline and the wider scientific community.
