We are looking for Co-Editors - Animal Welfare Book Series by Springer Nature

Aims and Objectives of the Series

At the turn of the century a new book series on animal welfare commenced, published by <u>Springer</u> <u>Nature</u>. This series has been designed to help contribute towards a culture of respect for animals and their welfare by producing academic texts addressing how best to provide for the welfare of the animal species that are managed and cared for by humans. Volumes in the series do not provide a detailed blue-print for the management of each species; rather they describe and discuss the major welfare concerns, often in relation to the wild progenitors of the managed animals. Welfare is considered in relation to animals' needs, concentrating on nutrition, behaviour, reproduction and the physical and social environment. Economic effects of animal welfare provision were also considered where relevant, as were key areas where further research is required.

Since its inception, the series has published about one book each year, mostly on the welfare of different groups of animals, but also some more general books, such as the links between animal welfare and nutrition, and stress and animal welfare.

Expansion of the Series

The Series Editor and Springer are looking to expand the series, so that about 3-4 books are published each year. This is beyond the capacity of the current Academic Editor, Clive Phillips, and the <u>Scientific</u> <u>Board</u> to manage, so additional Co-Editors are sought who will assist in this process. This task includes the scientific review of manuscripts and stimulation of new projects. It is expected that the Editorial Group will work as a team to ensure a steady supply of high quality texts in the field of animal welfare, in line with the original ethos of the series. Future volumes are planned in the welfare of companion animals, animals in bioscientific research, sustainable agriculture and environmental parameters, so Editors with an interest in these fields of study are particularly encouraged to apply.
